The selection is provisional and subject to compliance / fulfilment of the following broad terms and conditions:

1. The State Government assistance in the form of Margin Money / Subsidy will be to the extent of Rs.3.00 lakh for each beneficiary depending upon project cost, type of vehicle and purchase cost thereof.
2. The margin money assistance will be released directly to the authorised dealers of the vehicles(s)/financing banks of the units on behalf of the beneficiaries and the remaining part of cost and other charges would have to be arranged by the beneficiaries themselves. For other projects the assistance would be made in 2/3 instalments depending upon progress of works.
3. The vehicles will have to be registered in the name of the beneficiaries as commercial vehicles and in all cases a MOU would have to be signed with Assam Tourism Development Corporation Ltd.
4. Assam Tourism Development Corporation Ltd. will prescribe colour scheme for the units/ vehicles with Assam Tourism logo and inscription so that the vehicles / units will be identifiable easily from a reasonable distance and also for promoting the cause of Assam Tourism.
5. Other than the margin money / subsidy, the Assam Tourism Development Corporation Ltd. / Govt. of Assam shall neither be liable for any financial liability arising out this scheme in any manner nor shall be responsible for providing any guarantee for loan or such other matters for running the projects/vehicle on commercial basis by the beneficiaries.
6. The beneficiaries may have to produce again documents regarding qualification, age, unemployment etc. as may be called for relating to their selection.

The selected beneficiaries are hereby informed to collect the following documents from the office of the undersigned within 30 days from declaration of the result in the newspaper:-
